Terms & Conditions

2012 Annual Membership Fees:

The annual fee plus applicable taxes is payable on or before the 31st of December 2011 for your Tarandowah Golfers Club Membership card.

2012 Membership Privileges and Policies:

Members have no equity or ownership rights in or to Tarandowah Golfers Club. Members are entitled only to the privileges listed below.

Privileges:

1. Full members shall have full unrestricted playing privileges.
2. Range members shall have driving range privileges.
3. Members shall have billing privileges at Tarandowah.
4. Members guests shall receive a 25% discount off regular priced green fees.

Policies:

Membership Term and Course Availability: The annual membership term will be from the date of application acceptance to December 31, 2012. Club memberships are valid for the calendar year only.

Tee Time Reservations: Members will have the ability to reserve tee times ten days in advance. Members are responsible for the number of players reserved. Members can be charged for no-shows at clubs discretion.

Tee Time Cancellations: Tee time cancellations are required 24 hours prior to play regardless of weather conditions. Failure to properly notify the pro-shop of a cancellation will result in the full amount of the booking being charged directly to the members that made the reservation.

Cart Use: Cart use, subject to appropriate fees, members are charged \$17.00 per half cart.

Billing: Members will be entitled to charge all purchases at Tarandowah Golfers Club (with the exception of tournaments and similar large events determined at the discretion of management) to their account for monthly billing. A credit card number in our files is needed for this privilege. Each member can view online their monthly statement (www.puregolf.net) thru their tara account at the end of each month summarizing all monthly purchases and payments will be applied on the 15th. The member authorizes Tarandowah Golfers Club to charge the credit card listed in their application for all charges incurred by the cardholder. Delinquent accounts will be subject to an interest rate of 2% per month and may result in suspension of account and playing privileges.

General: Golf members and their guest must abide by the rules and regulations and respect the rights of all fellow golfers, guests and staff members. Failure to do so may result in the member's privileges being suspended. Suspended members are not entitled to any refund of the membership fee but may appeal their suspensions to Tarandowah's board of Directors.
